

BOLD IMPROVING BUSINESS ENVIRONMENT

BOLD PERFORMANCE ON TOP PRIORITIES IN 2017

In 2017, AmCham Serbia conducted its traditional survey among its members on Investors Satisfaction and Confidence, aimed at identifying key reforms necessary to further improve business environment. Out of top priorities that were chosen by AmCham members, significant results have been achieved in recent period.

A major step forward in 2017 is the continuation of the **reform of parafiscal charges** with adopted amendments of the Law on Administrative Taxes, and publishing for proper public discussion Draft Law on Compensations for the Use of Public Goods.

In 2017 the grounds were laid for the formation of special privatepublic dialogue platform, chaired by Public Prosecutor's Office and aimed at curbing illicit trade over internet and better IPR enforcement. After 3 years of insisting on the importance of proper regulation of the data protection in line with EU standards, **Draft Law on Personal Data Protection** was put to the public discussion, with the strong basis in the EU regulations.

Top priority recommendation of AmCham Trade Facilitation Committee -the establishment of National Trade Facilitation Committee, as a platform for public-private dialogue between relevant authorities on much needed trade facilitation measures, was finally accomplished in 2017.

Finally, based on our members' demand, we have decided to **expand the mandate of Real Estate Committee** in 2017, by introducing a new set of energy and infrastructure topics!

























BUSINESS AND CORPORATE LAW COMMITTEE

Business and Corporate Law
Committee focused its efforts in 2017
on the improvement of the personal
data protection regulation and its
proper enforcement.

By participating in the public discussion on **the Draft Law on Personal Data Protection**, AmCham stressed the importance of further regulating data processing in specific areas, necessity of defining consent to personal data processing, recognizing EU Model Clauses and extending the transitional periods for the law implementation.

Earlier in 2017, AmCham organized a Briefing Session with the Commissioner to discuss necessary improvements to the Model Law on Personal Data Protection and implementation of the current Law, especially in terms of personal data export.

Moreover, AmCham prepared an informative Briefing Session on the GDPR Implementation,

which underlined necessary steps companies need to take to become compliant with the EU regulation. Highly informative Briefing Session on Data Protection in Arbitration Cases highlighted challenges with document discovery in arbitration procedure.

Upon invitation from the Commission for Protection of Competition,

AmCham named a representative in the working group in charge for drafting Amendments to the Competition Law, which is expected to be published in 2018.

Bankruptcy Law with some AmCham comments was adopted in 2017, however missing the opportunity to fully strengthen the position of creditors, and remove bottlenecks existing in practice.

Finally, Committee also provided suggestions for the improvement of the current **Company Law**.

FINANCE AND TAX COMMITTEE

Ministry of Finance has finished 2017 with a good practice - by publishing the long-awaited **Draft Law on** Compensations for the Use of **Public Goods**, allowing proper access and time for public discussion. The adoption of this law in 2018, in line with AmCham's suggestions. will be an important initial step in reducing unpredictability of tax laws amendments and continuation of the reform of parafiscal charges.

The year ended with amendments of the 5 tax laws that entered Government procedure after only two days of public insight. The adopted regulations brought important improvements such as tax reliefs for the startups and the basis for regulating administrative taxes in one law, however failing to fully take stock of the suggestions of the private sector.

In 2017. Committee commented on the **Draft Law on Interchange**

Fees and Special Rules of Dealing with Payment Transactions based on Payment Cards published by National Bank of Serbia and provided recommendations that could address some of the possible negative effects.

At the beginning of 2017 Committee organized Briefing Session on VAT Law Implementation with relevant representatives of Ministry of Finance. Furthermore, AmCham provided suggestions for simplifying the Draft Rulebook on keeping VAT records whose application was, once again, postponed after serious pushback of the whole business community.

By the end of the year, AmCham held a very informative **Briefing Session** on Criminal Liability for Criminal Offence of Tax Evasion. which gathered representatives of Tax Administration. Tax Police and Public Prosecution, offering conclusions relevant for practice and regulatory changes.

COMBATING GREY ECONOMY COMMITTEE

As the focus of Combating Grey Economy Committee shifted in 2017 from inspections oversight of traditional markets to the internet sphere, Committee's recommendation to establish a special private-public dialogue platform aimed at curbing illicit trade over internet and better IPR enforcement, was supported by Public Prosecutor's Office.

After first consultation meeting which included all interested parties, it was decided to establish a working group composed from representatives of the business sector, all relevant inspections, Ministry of Interior and Customs Administration, chaired by Public Prosecutor for High Tech Crimes.

The aim is to jointly identify regulatory and implementation bottlenecks in inspection oversight and prosecution of online illicit trade cases, as well as to propose measures for overcoming them.

In 2017, Committee's members actively contributed in **including Serbia in the Economist's Report on Illicit Trade Environment Index**, which should map the extent of illicit trade in the Serbian market and help raise awareness on the necessity of addressing this issue.

Finally, Committee once again participated in drafting the revised Government's Action Plan for Fighting Grey Economy, with proposals aimed at more efficient prosecution of grey economy cases and inspections oversight.

ENVIRONMENTAL COMMITTEE

The breakthrough in 2017 was the establishment of the separate **Ministry for Environmental** Protection, which has been in the focus of Environmental Committee's advocating efforts, along with the need to raise Ministry's administrative capacities, to achieve better inspection supervision and consistent collaboration with the private sector.

During second half of the year, Committee members had a series of meetings with key Government stakeholders, including the newly appointed Minister of Environmental Protection and his cabinet.

In September, AmCham initiated a Briefing Session on Packaging and Packaging Waste with representatives of Waste

Department at the Ministry of Environmental Protection, which resulted in joint set of conclusions on priority measures for intensifying the collection and recycling of packaging waste.

To top it all, AmCham organized a highly successful Conference on Environmental Protection

- Waste Management, opened by Minister Trivan and U.S. Ambassador Scott, attended by representatives of Government, local self-governments, private sector, Europen, local and regional waste operators. Conference raised attention about the most burning issues in the area of packaging waste and special waste streams management.

HEALTH CARE COMMITTEE

First half of 2017 was dedicated to the public procurement in health care, through series of Health Care Committee roundtables related to analysis of centralized INN procurement effects, use of quality criteria in public procurement and innovative forms of medicines' contracting.

Recommendations from the public procurement roundtables, as well as the ones made in the joint study by AmCham and the Ministry of Health on the improvement of health care efficiency, were reviewed at the annual **Conference on the Development of Health Care Policies in Serbia**, attended by all relevant public authorities, private sector, international and local experts in the field.

Meetings with Ministry of Health's Subgroup for the Development of Health Care Strategy, NHIF and ALIMS in 2017, proved to be useful to directly discuss priority steps in health care reform and learn about Government's plans in this regard.

In 2017, Committee continued its activities related to the improvement of health care legislation. Majority of AmCham's suggestions were accepted as integral part of the Draft Law on Medical Devices, as well as in the finalized drafts of the Law on Health Insurance

Towards the end of the year, Committee initiated discussion with Agency for Medicines and Medical Devices regarding sudden hike in fees, while maintaining the average delay in its operations.

The reduction of grey economy among the providers of the health care services was included as a new topic on the Committee's agenda, followed by meetings with Tax Administration and participation at the panel discussion within The Economist's conference World in 2017

LABOR REGULATIONS COMMITTEE

Labor Regulations Committee has been active in advocating for the adoption of the Staff Leasing Law, which would create more effective and accessible legal framework, by defining rights of both workers and employers and reduce possibilities of abuse. Briefing Session on Draft Staff Leasing Law organized in August 2017 with members of the working group in charge for its drafting, proved to be a great platform to learn about Government's plans for the adoption of this highly anticipated regulation.

Briefing Session on Inspection
Supervision with Labor Inspectorate
was an opportunity for AmCham
members to raise their concerns
about implementation of labor, safety

and health at work regulations and receive proper clarifications from the persons directly in charge for inspections oversight.

On the regulatory side, certain progress in reducing red tape has been made by the new **Proposal Law on Foreigners**, which was improved in line with Committee's suggestions and harmonized with the EU directives.

AmCham was also active in raising attention about the significant negative impact of **changes in interpretation and implementation of the Law on Employment of Foreigners by National Employment Service** regarding renewal of working permits for posted workers.

REAL ESTATE AND ENERGY COMMITTEE

Based on members demand, energy and infrastructure topics were introduced in the agenda of the newly formed Real Estate and Energy Committee. After many of bilateral meetings with companies operating in the energy and mining industry, Committee's focus was put on improving the legal framework for PPPs in this area, better implementation and enhancement of specific regulations around renewable energy and supporting the development of novel energy business models.

In September 2017, Committee representatives had an **introductory meeting with Minister of Mining and Energy, to present the agenda of the newly formed Energy** Subgroup and agree on cooperation. As one of its first activities, the Subgroup provided comments on the

Draft Decree on the Energy Strategy Implementation Program for 2017 - 2023.

In a written letter to the Ministry of Construction, Transport and Infrastructure, Committee advocated for the official public discussion on the Draft Law on Registration in the Cadastre. In July 2017, AmCham suggested significant changes to the Draft Law, followed by consultations with members of the working group in charge for its drafting.

TRADE FACILITATION COMMITTEE

Top priority recommendation of AmCham Trade Facilitation Committee - the **establishment of National Trade Facilitation Committee**, as a platform for public-private dialogue between relevant authorities on much needed trade facilitation measures, was finally accomplished in 2017.

As per AmCham`s suggestion, this body will be based on the model of Coordination Commission for Inspections Oversight, to include both representatives of state and businesses and will be co-chaired by Ministry of Trade, Tourism and Telecommunications and Customs Administration.

AmCham Public-Private Dialogue for Trade Facilitation Conference organized in partnership with USAID in November, highlighted the importance of identification and resolution of obstacles for more efficient import-export procedures that would lead to more intensive economic growth.

Two conference panels tackled the removal of non-tariff barriers through the newly established National Trade Facilitation Committee as well as in the context of the CEFTA agreement and other regional initiatives.

DIGITAL ECONOMY PLATFORM

Collaboration between
AmCham and the newly formed
Government's Office for IT and
eGovernment was kick-started
with the special **Briefing Session**with **Director Mihailo Jovanović**,
who presented the organization,
upcoming activities and projects of
the Office.

With the Law on eDocument, eldentification and eTrust Services adopted in the second half of 2017, with AmCham comments incorporated, **Briefing Session** on this topic with representatives of Ministry of Trade, Tourism and Telecommunications, served as a platform to discuss key novelties that the Law brought and further plans for its implementation.

The importance of and means for successful establishment of cyber security and the risks that stem from digitization were in focus of special **Briefing Session on Cyber Security**, gathering representatives of public, private and civil society sector.

Regulatory wise, AmCham provided comments to the Draft Law on eGovernment and warned about significant negative impacts of the newly introduced obligation of state authorities to migrate their email accounts and data records on servers located in Serbia.

Synergy between corporations and startup community further explored in 2017 through **several meetups** with **StartIt and ICT Hub**.



New generation of AmChampions

AmChamps Class of 2017 included 42 new participants — 21 prospective young managers from member companies and 21 exceptional, final-year students from more than 10 Belgrade University faculties.







































































































































































