IMPROVING BUSINESS ENVIRONMENT

AmCham Serbia in collaboration with IPSOS Strategic Marketing conducted its traditional Lap Time survey for the 10th time among its members, as well as SMEs outside membership, identifying key reforms necessary to further improve business environment.

Priorities for the new Government:

Continuing comprehensive **digital transformation** in Serbia, focusing on three key goals – raising efficiency of the government and business sector, recognizing opportunities for the development of innovative technologies and ensuring high level of security in the access to and use of electronic services and databases.

Achieving tangible results within the **Green Agenda**, focused on two specific areas. In the energy field, securing energy stability in times of crisis and creating the framework for green energy transition. On the side of environmental protection, driving a careful design of the deposit return system for the effective packaging and packaging waste management.

Establishing efficient and well-organized **health care** system, by initiating necessary changes to the Law on Medicines and implementing regulations to facilitate access to new medicines, implementation of digital solutions and larger inclusion of private health care sector, as well as positioning Serbia as a country that values innovation.

Improving **regional economic cooperation**, primarily through continued focus on EU integrations, as well as supporting further development of the Open Balkans Initiative, through improved implementation of the signed agreements and expanding the areas of cooperation.

Topics in the focus in 2022:

Supporting enforcement authorities in Serbia and in the region in establishing more efficient **supervision of software legality**, through series of software licensing trainings.

Facilitating closer regional ties, exchange of information and better cooperation between the private sector and enforcement authorities tasked with **oversight of illicit trade and IPR protection**.

Carrying out analysis and proposal of changes to the Law on Medicines, aimed at streamlining the administrative procedures for marketing authorizations, clinical trials, promotional materials, as well as enabling (regulating) modern use of sales channels for medicines.

Offering a platform for interested member companies to discuss and examine key aspects of the design and implementation of the deposit return system, structured so as to create an effective, yet sustainable system that would be beneficial for all stakeholders.









Participation in the USAID project aimed at focused on improvement of **protected areas management** in Serbia, with a mandate to propose changes to the system of charges in the protected areas, as well as exploring and promoting cooperation between the industry and protected areas.

Supporting the design of the regulatory framework, that would incentivize the development of renewables projects and take into account the global energy crisis.

Showcasing the emerging reality of Environmental Social Governance (ESG) and its impacts on how the industry will change, through the **ESG Champions Initiative** in cooperation with Kearney.

Briefing Session on Green Financing shed light on the implementation of the ESG standards/EU taxonomy in the Serbian banking sector and how these policies are dictating the ways companies will seek finance.

Conducting a Survey on the results of trade facilitation initiatives implemented under the Open Balkan Initiative (OBI) and Overview of restrictions to the free flow of capital in OBI countries, aimed at measuring tangible outcomes for businesses stemming from OBI, as well as defining further opportunities in easing doing business in the region.

Organizing a well-attended **Seminar on elnvoicing** implementation issues and upcoming obligations for businesses with the Ministry of Finance.

Ongoing support to members in **overcoming systematic tax administration issues**, by pointing out to a widespread issue of taxation of nonresident employees which caused unnecessary and excessive fiscal and administrative costs to businesses.

Submitting proposals for amendments of **Draft Laws on eFiscalization, eInvoicing and VAT** to the Ministry of Finance.

Supporting the members in overcoming issues with **implementation of the newly adopted Law on Fiscalisation**, focusing on the issue of fiscalization of services in retail facilities, which was resolved by clarification under which services of positioning goods are not subject to fiscalization obligations.

Submitting the **Double Tax Avoidance Treaty initiative**, as a business case for the U.S. Government to enter into negotiations with Serbia on concluding a bilateral Double Tax Treaty.

Development of eBusiness and eGovernment – calling for the wider use of electronic documents in labor regulations, through the Opinion of the Ministry of Labor.

Launching a series of roundtables "Business in Times of the Global Crisis" focusing on macroeconomic outlook, energy stability prospects and real estate trends.









NETWORKING AND PROMOTION

The event making **two decades of AmCham** was attended by Serbian Prime Minister Ana Brnabić. The attendees, representing AmCham member companies, partners, and associates, toasted the anniversary.

More than 130 attendees from both AmCham member companies and Banca Intesa corporate clients, marked 15 years of working together at the **Business After-Hour Cocktail**.

The traditional **Thanksgiving Dinner** was held on the 31st floor of Skyline AFI Tower in the presence of representatives of AmCham member companies with their families. The holiday was marked in the spirit of gratitude that brings us happiness.

The landmark 10th Lap Time Conference on improving business environment priorities identified in AmCham's traditional Survey was attended by Serbian Prime Minister Ana Brnabić, Minister of Mining and Energy Dubravka Đedović, Minister of Internal and Foreign Trade Tomislav Momirović and Minister of Information and Telecommunications Mihailo Jovanović.

















EXCELLING PROFESSIONAL DEVELOPMENT

Despite the epidemiological situation, **AmChamps Class of 2021-2022** successfully finished the program, with most of the curriculum activities conducted online. In October, AmChamps welcomed its 8th generation – **AmChamps 008**, gathering 25 students & 25 young managers from AmCham member companies.

AmChamps 008 is supported by the York University - Europe Campus City College, MK Group, Ball Packaging Europe, Coca-Cola Hellenic, MSD, Philip Morris, Telegroup, PWC, Nedeljnik, Gi Group, Jelena Kralj and Crowne Plaza.

HR Forum continuously proves to be one of the most vibrant among our standing forums in 2022, discussing challenges facing the HR sector, wage trends in the labour market, the importance of employee's mental health, creating psychologically safe business environment, and back to office experiences.

AmCham Serbia has joined the **EMPOWER HER initiative**, which aims at promoting the economic empowerment of women in the workplace, women in leadership positions, and women entrepreneurs, and is based on a partnership between the US Department of Commerce, AmCham EU and AmChams in Europe, with the involvement of American businesses operating in Europe. As part of this initiative, a **panel discussion** was organized, hosting Violeta Jovanović of NALED, Vesna Damjanic of Bloomberg Adria, Nina Čaprić of NCR Corporation and Jasmina Knezević of ACIBADEM Bel Medic. The event was opened by Ivan Miletić in a role of AmCham First Vice President, followed by addresses of Brankica Janković, Commissioner for the Protection of Equality and video addresses of Susan Danger, CEO, AmCham EU and Pamela Ward, Regional Senior Commercial Officer, U.S. Department of Commerce.





















INDEPENDENT PRACTITIONER'S REVIEW REPORT

TO THE TO THE MANAGEMENT OF THE AMERICAN CHAMBER OF COMMERCE IN SERBIA

We have reviewed the accompanying financial statements of the American Chamber of Commerce in Serbia (hereinafter referred to as "the Association") which comprise the balance sheet as of 31 December 2022 and the income statement and related Notes for the year then ended (hereinafter the "financial statements"). The financial statements have been prepared by management of the Association based on the financial reporting provision described in Notes 2 and 3.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation of these financial statements in accordance with the accounting regulations prevailing in the Republic of Serbia, based on the Law on Accounting ("Official Gazette of the Republic of Serbia", no. 73/2019 and 44/2021) and accounting policies described in Notes 2 and 3, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying financial statements. We conducted our review in accordance with the International Standard on Review Engagements (ISRE 2400 (Revised), "Engagements to Review Historical Financial Statements". ISRE 2400 (Revised) requires us to conclude whether anything has come to our attention that causes us to believe that the financial statements, taken as a whole, are not prepared in all material respects in accordance with the applicable financial reporting framework. This Standard also requires us to comply with relevant ethical requirements.

A review of financial statements in accordance with ISRE 2400 (Revised) is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates evidence obtained.

The procedures performed in a review are substantially less than those performed in an audit conducted in accordance with International Standards on Auditing. Accordingly, we do not express an audit opinion on these financial statements.

Conclusion

Based on our review, nothing has come to our attention that causes us to believe that the financial statements of the Association are not prepared, in all material respects, in accordance with the accounting regulations prevailing in the Republic of Serbia, based on the Law on Accounting and accounting policies described in Notes 2 and 3.

Emphasis of Matter

We draw attention to the Note 2 to the financial statements which describes the basis of accounting. The accounting framework used in preparing these financial statements does not comply with all requirements of International Financial Reporting Framework. Our conclusion is not modified in respect of this matter.
